

# What is Cancel for Any Reason (CFAR)?

---

No one looks forward to canceling a trip, but sometimes it is necessary. Cancel for Any Reason is a benefit that allows you to cancel your trip regardless of the reason. With the benefit, you may be eligible for up to 75% reimbursement of your pre-paid, non-refundable trip costs.\*

**The benefit means what it says. You can cancel for *ANY* reason.**

- Requires your reason for cancelling to be listed in the plan
- Covered reasons are eligible for up to 100% reimbursement of pre-paid, non-refundable trip costs.

## CFAR ELIGIBILITY

**To be eligible you must:**

1. Purchase a Worldwide Trip Protector Plus plan within 21 days of the date your first

trip payment or deposit is received by your trip supplier.

2. Insure all pre-paid, non-refundable trip costs. Also insure subsequent travel plans within 21 days of paying for them.

3. Cancel the trip 48 hours or more before the scheduled departure date.

**Note: CFAR is not available for residents of New York State.**
