



Navigo Sports Tours Sweepstakes Rules

Effective Date: January 1, 2026

1. Eligibility

The Sweepstakes is open only to legal residents of the United States who are 18 years of age or older at the time of entry and where participation is not prohibited by law.

Employees of Navigo Tours LLC, its affiliates, subsidiaries, advertising and promotion agencies, and immediate family members or members of the same household are not eligible to participate.

Current travelers participating in a Navigo Sports Tours trip (including athletes, coaches, and traveling family members such as parents or guardians who are part of the official tour group) are not eligible to win prizes.

Non-traveling family members, friends, and supporters of participants are eligible to enter and win, provided they meet all other eligibility requirements.

The Sweepstakes is subject to all applicable federal, state, and local laws and regulations.

2. Agreement to Rules

By participating, entrants agree to be fully and unconditionally bound by these Rules and represent that they meet all eligibility requirements. Entrants agree that Navigo Tours LLC's decisions regarding the Sweepstakes are final and binding.

3. Sweepstakes Period

Entries will be accepted beginning on or about July 1 each year and ending June 30 of the following year. All entries must be received by June 29 at 11:59 PM EST to be eligible for the drawing on June 30.

4. How to Enter

To enter the Sweepstakes, participants must complete an official Navigo Sweepstakes ticket stub and submit it in accordance with the instructions provided.

Each completed and valid stub constitutes one entry once properly received and validated.

All entries must include required contact information, including name and at least one method of contact (email or phone number). A mailing address is also requested. Incomplete, illegible, or unverifiable entries may be disqualified at the sole discretion of Navigo Tours LLC.



Each individual is limited to a maximum of five (5) entries total during the Sweepstakes period. Entry limits are enforced using a combination of name, email address, phone number, and mailing address to prevent duplicate entries.

Entries must be submitted by mail or returned according to the instructions provided in the official fundraising materials. Fraudulent, duplicated, or tampered entries may be disqualified.

Ticket stubs are available upon request. No donation or payment is required to receive or submit a ticket stub.

5. Prizes

Navigo Tours LLC may use winners' names and likenesses for promotional purposes where permitted by law.

6. Odds

Odds of winning depend on the total number of eligible entries received.

7. Winner Selection and Notification

Winners will be selected in a random drawing conducted by Navigo Tours LLC. Winners will be notified via email within five (5) days following the drawing.

Navigo Tours LLC is not responsible for missed notifications due to spam filters, incorrect contact information, or delivery issues. If a winner cannot be contacted or fails to claim the prize within 90 days, an alternate winner may be selected.

8. Rights Granted

By entering, participants grant Navigo Tours LLC permission to use their entry information, name, likeness, and statements for promotional and marketing purposes, where permitted by law, without additional compensation.



9. Terms

Navigo Tours LLC reserves the right to cancel, modify, or suspend the Sweepstakes if necessary due to fraud, technical issues, or other factors beyond its control.

Any attempt to tamper with the entry process may result in disqualification. Navigo Tours LLC reserves the right to void any entries deemed fraudulent, excessive, or inconsistent with the intent of the Sweepstakes.

10. Limitation of Liability

By entering, participants release Navigo Tours LLC and its affiliates from any liability arising from participation in the Sweepstakes or acceptance of any prize.

11. Disputes

This Sweepstakes is governed by the laws of the United States and the State of New Hampshire. Any disputes shall be resolved individually in a court located in New Hampshire. Participants waive the right to class action claims.
